What is your role in your Committee?

Chairing these committees is fascinating and exciting.

What are the main challenges facing your Committee/practitioners at the moment?

For both committees, the need for governments to raise more tax means that the role of practitioners is increasingly in the sights of state organisations. Anti-avoidance rules, automatic information exchange and trust registers are all very much on the agenda.

How will you deal with these?

STEP members face enormous challenges in order to provide independent advice and service in an increasingly globalised and complex world. However, these threats also provide extraordinary opportunities for those of us who can service cross-border needs. Training and networking will be the key to keeping ahead of the game.

What's the best piece of advice you've been given?

My *Taid* (grandfather in north Welsh) always said, 'Keep your feet warm, your bowels open and your word, and remember a Frimston is never beat'.

## What's been your career highlight?

I have presented evidence to various Parliament committees, including the UK House of Lords and the EU Parliament. In January 2013, I was pleased to be able to raise awareness regarding cross-border incapacity issues and the Westminster government's petty minded failure to follow the Scots ratification of Hague Convention 35.
