- If you instruct a bank you may still need to instruct a solicitor to deal with some aspects of the administration such as selling a property
- Some banks insist on acting through a power of attorney so that they alone make all the key decisions such as the sale price of a property or when to make interim distributions. Russell-Cooke is happy to act for the Executors appointed in the Will letting the Executors make the key decisions. If the Executors, however, want to hand the entire administration over to Russell-Cooke Trust Company for peace of mind then

they can do so
